

**Hobcaw Yacht Club Grassy Area Day Sailing Sailboat Parking**  
**Registration Agreement and Policy**

We want to encourage our active day sailors to utilize our boatyard and have created a parking area to make easier for them to sail out of Hobcaw Yacht Club. It is the grassy area beside the pool in the boatyard right next to the HYC Sailing School sailboat parking. This area has blue signs that say “Membership Parking.”

It is a first come, first serve basis and available for our recreational day sailors or racing sailors to park their “day sailing” sailboats from April 1<sup>st</sup> to November 1<sup>st</sup> each year. All that we require is for you to complete the following registration form so that we can identify each sailboat and sailboat owner and place the registration sticker on the trailer or boat dolly tongue.

1. **PARTIES TO AGREEMENT** The parties of this Registration Agreement are the Hobcaw Yacht Club, PO Box 21, Mt. Pleasant, SC 29465, hereinafter referred to as HYC, and \_\_\_\_\_ hereinafter referred to as Sailor.

3. **DURATION:** This Registration Agreement duration is valid for the Sailboat parking from April 1st to November 1st in the Grassy Knoll area within the boundaries of the Blue Membership Parking Signs unless otherwise directed by the Boatyard Manager.
4. **REGISTRATION AMOUNT AND PAYMENT:** The Registration amount is \$15 payable when your registration sticker is picked up and valid as long as you are a HYC member in good standing.
5. **SAILBOAT USE REQUIREMENT:** The grassy knoll area is not for long-term boat storage. This area is for active day sailors and their day sailing sailboats. Sailor agrees to use their Sailboat a minimum of Eight (8) days per sailing season (Apr to Nov). Violation of this use requirement shall be cause for termination of the Registration Agreement.
6. **SAILBOAT DAMAGE LIABILITY:** Sailor agrees that Sailor will be held responsible for any damage, which Sailboat and or Trailer may cause, by any means, to other Sailboats in the Hobcaw Yacht Club Boatyard or to the Hobcaw Yacht Club structures, equipment or facilities.
7. **INDEMNIFICATION:** Sailor agrees to defend, indemnify and hold harmless HYC, its Board Members, managers, agents and assigns for any and all claims, damages, losses, demands, causes of actions or liabilities of any kind, including attorneys’ fees, for personal injuries including death, or damage to property arising out of use by Sailor (including Sailor’s family, agents, guests or invitees) of the Sailboat, or the mooring of the Sailboat by Sailor.
8. **SAILBOAT IS IN GOOD CONDITION:** Sailboats not in good working condition will not be admitted to the Hobcaw Yacht Club. Failure to maintain the Sailboat in good condition shall be cause for

termination of the Registration Agreement. The condition of the Sailboat shall be appraised and determined by the Hobcaw Yacht Club Board, in its sole discretion. All decisions of condition and maintenance of good condition made by the Hobcaw Yacht Club Board shall be final and binding on the parties.

9. HYC NOT LIABLE FOR FIRE, THEFT, ETC: HYC and its Boatyard Manager will take all reasonable precautions to protect the safety and property of Sailor. However, HYC and its Boatyard Manager assume s no responsibility for the safety and any Sailboat moored in the Hobcaw Yacht Club and will not be liable for fire, theft, damage or vandalism to Sailor’s Sailboat, its equipment, appurtenances, engines, dinghies, etc., however arising; it being the parties understanding that Sailor shall moor and or park the Sailboat at Sailor’s own risk.

10. MISCELLANEOUS TERMS:

- a. Sailor agrees to keep dry slip free of trash and debris regardless of its origin.
- b. Sailor agrees to promptly move the Sailboat when given advance notice of boatyard maintenance and repairs and grants HYC or its agent permission to move the Sailboat during these times.
- c. Sailor is responsible for removal of Sailboat in the event of a weather emergency.

I certify that I have read and agreed to the above terms and that I will agree to abide by the current Rules and Regulations of the Hobcaw Yacht Club.
